

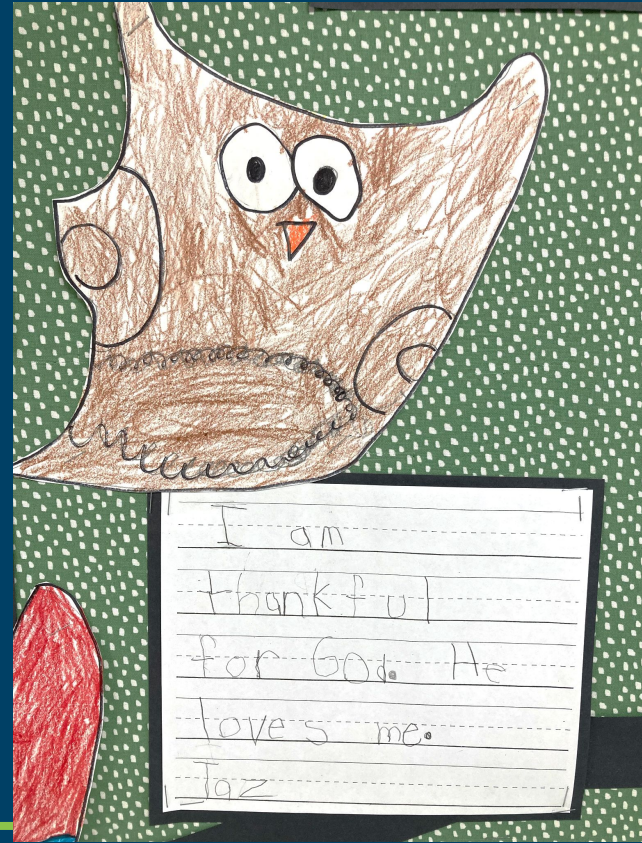

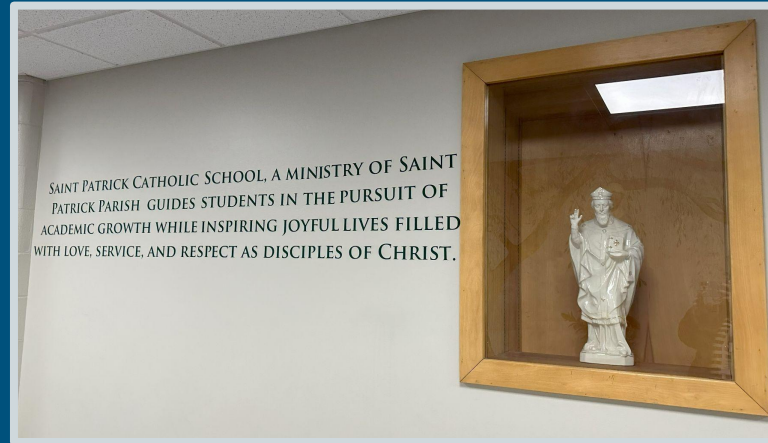

- SPCS will intentionally provide UDL and Responsive Classroom training for new teachers and provide parent education specific to the strategies and outcomes of UDL.
